Supervisor Johnson asked for a moment of silence in honor of New York State Trooper Timothy Pratt.

Supervisor Johnson said the tentative budget was introduced last month. The town board had a budget workshop and made some changes. Before the public hearing, he said he would like to go over those changes.

Supervisor Johnson said the total additions to the budget were \$185,671. The majority of that increase is for a plow truck for Corinth Mountain Road. There was also a storage trailer for the highway department. Some drainage issues for the engineering department. \$19,000 was added for the Bicentennial Committee to work with. We added a part time director for our seniors. There was a deletion of a pickup truck that was in the tentative budget but was taken out. The net result is \$185,671. The tentative budget was 8,051,671 and the budget we are voting on tonight is \$8,337,342.

Approve Pending Minutes

On a motion introduced by Deputy Supervisor Streicher, the board adopted the following resolution:

Supervisor Johnson noted Councilman Lant was going to be late and would like to wait and vote on the budget after he arrives.

No Parking Signs-Northern Pines Road/Davidson Drive

Supervisor Johnson said the Town Clerk received a letter from Mr. Havarnak who lives on Davidson Drive. He would like "No Parking" signs on Northern Pines Road and Davidson Drive. Mr. Havarnak indicated some problems with visibility due to vehicle parking along that area. Northern Pines Road is a county road and the county is looking for a resolution in support of the signs. **Highway Superintendent Woodcock** said the signs are up on Davidson Drive. Northern Pines Road is a county road and is the county's responsibility.

On a motion introduced by Councilwoman Klepetar, the board adopted the following resolution:

Not on the Agenda

Councilman Lant said many years ago we had quite a few injuries and deaths due to accidents at Route 9 and Ballard Road. It took a long time before anything was done. Two weeks ago, we had a tragedy on Ballard Road. The road is not aligned well; there is a school, a firehouse and tractor trailers. We should have the county and state look into it again. The speed limit is 55 mph. **Supervisor Johnson** said a speed limit request was sent to the county in 2013. We did get a response but circumstances change. **Supervisor Johnson** said he would certainly entertain putting another request in. We have no control over the speed limit. The prior request was for signage at the school and for a speed limit reduction. New York State responded to the request and stated neither had to be done.

On a motion introduced by Deputy Supervisor Streicher, the board adopted the following resolution:

NOW, THEREFORE, BE IT RESOLVED, to request a safety analysis and a speed limit reduction on Ballard Road between Exit 16 and Route 9.
