Exit 16 Linkage Study Resolution

RESOLUTION OF THE WILTON TOWN BOARD REGARDING

THE WILTON EXIT 16 LINKAGE STUDY

WHEREAS, the Capital District Transportation Committee (CDTC) is the designated metropolitan planning organization (MPO) for transportation planning and programming in the metropolitan area of Albany, Rensselaer, Saratoga, and Schenectady counties; and,

WHEREAS, CDTC has an adopted metropolitan transportation plan known as *New Visions 2030*, the principles of which are incorporated into CDTC's Community and Transportation Linkage Planning Program (hereby known as the "Linkage Program"); and,

WHEREAS, the Town of Wilton has applied for a 2010-2011 Linkage Program study known as the *Wilton Exit 16 Linkage Study;* and,

WHEREAS, the proposed *Wilton Exit 16 Linkage Study* area includes Ballard Road, owned and maintained by Saratoga County, and Exit 16 of I-87, owned and maintained by the New York State Department of Transportation (NYSDOT); and,

THEREFORE BE IT RESOLVED that the Town of Wilton pledges to work with the CDTC, Saratoga County and NYSDOT on the *Wilton Exit 16 Linkage Study* utilizing CDTC's *New Visions 2030* and Linkage Program planning principles; and,

BE IT FURTHER RESOLVED that the study will develop an integrated land use and multi-modal transportation vision for the *Wilton Exit 16 Linkage Study* area. Concepts to be explored will include site design and building placement, access management, pedestrian and bicycle access, public transit, park and ride lot development, and safety and operational improvements to the Ballard Road/Exit 16 study area consistent with the Town's and CDTC's adopted plans.

BE IT FURTHER RESOLVED that the Town of Wilton will commit local staff to assist with the administration of the study jointly with a staff person from CDTC through the duration of the study in 2011; and,

BE IT FURTHER RESOLVED that Saratoga County will be an active partner in the study efforts, and whose staff time from the Departments of Public Works and Planning will contribute to the in-kind services portion of the local match,

BE IT FURTHER RESOLVED that the Town of Wilton will be represented on the Study Advisory Committee guiding the study; and,

BE IT FURTHER RESOLVED that the Town of Wilton will employ multiple methods to seek the perspective of residents, businesses and property owners in the study area.

BE IT FURTHER RESOLVED that the Town of Wilton pledges to work with Saratoga County and NYSDOT to explore the implementation of the *Wilton Exit 16 Linkage Study* land use and transportation recommendations

NOW, THEREFORE, BE IT RESOLVED, to approve the resolution with the \$13,500 Town match minus any allowed in-kind services comes from the Mitigation Fee Fund.

The adoption of the resolution was seconded by Councilman Gerber, duly put to a vote, all in favor, except Councilman Pulsifer, who voted nay (Motion carries 4 to 1).
