## Special Collection Day for Household Hazardous Waste DEADLINE TO REGISTER SEPTEMBER 8, 2021

**Collection Date:** Saturday, September 18, 2021

**Time:** 8:30 AM to 2:00 PM (each registrant will be assigned a specific time)

**Location:** Wilton Town Hall - Highway Garage, 22 Traver Road, Wilton, NY

Please Read Carefully. Retain this instruction sheet for your reference.

To participate in the Special Collection Day:

1. Print and fill out the registration information in PRINT format. Be sure your **Email** information is clear, so you can receive your assigned time for drop-off. Write it above the email box if you need more space.
2. Estimate the quantities of waste types that you want to dispose. Example: You have 4 total cans but they total 1 gallon.
3. Sign and date the form. Return the form by email, regular mail or drop it off at Town Hall. If emailing the form, your typed name constitutes your signature. Return the form no later than September 8<sup>th</sup> to participate.
4. If you are not sure if an item is acceptable enter it on the form. Your completed form is subject to approval by the Special Collection Day Project Committee. Eligible materials will be registered for collection.
5. A copy of the form will be returned to you by email or mailed to you with your assigned time. ***Items highlighted or crossed out on the returned form are NOT ACCEPTABLE items.***
6. Bring your returned registration form indicating your scheduled time and proof of residency to the drop-off site on Sept. 18<sup>th</sup>.

**NON-ACCEPTABLE ITEMS INCLUDE: LATEX PAINT, TIRES, PROPANE TANKS, FIRE EXTINGUISHERS, MICROWAVES, AIR CONDITIONERS, APPLIANCES, SMOKE DETECTORS, ALKALINE BATTERIES, FIRE EXTINGUISHERS, CAR BATTERIES, USED OIL, WIRELESS PHONES, AIR CONDITIONERS, APPLIANCES, SMOKE DETECTORS, BULK METAL, ELECTRONICS**
